Before you log in, you can select Search Courses.

You will need to contact the provider directly to get a list of their course offerings.

Your initial User ID is "L" plus your License Reference Number. ex: L1234567

What's my Password the first time I log in?

Your initial password is "L" plus your License Reference Number plus the last 4 digits of your SSN. ex: L12345670000

What is my License Reference Number?

You can find your reference number listed on your license provided by the Real Estate Commission in New Jersey. Please click <u>here</u> if you need an up-to-date copy of your license.

Why do I need an email if I use my reference and social security numbers?

It is recommended that after logging in, you click on **My Account** to add an email address.

How does my broker know about my continuing education?

Continuing education updates are sent to the Real Estate Commission each night. If you see **Requirements Met**, your work has been reported.



How do I print the transcript?

Select the **Overview** at the top or bottom right. Select **Printer Friendly** from the orange window that appears.

Why doesn't my instructor account show the courses I've taught?

Your sales or broker license is handled separately from your instructor account. Course completions, including those you have taught, should be listed under your sales or broker account. A different email address is required for each account.
