General Information

There is one (1) exam for this program (Note: there are eight (8) different forms of the National Registry of Certified Medical Examiners exam). General rules allow for test center issued scratch paper and test center issued pencil.

Check-In Requirements

- 1 unexpired Government-issued photo ID that bears the candidate's first and last name. First and Last name on ID must match the name in the PSI system (for any discrepancies, use the Acceptable Names Discrepancy document to determine if the candidate's name variance will be permitted).
- The following are acceptable forms of identification:
 - U.S. driver's license with photograph
 - State ID card with photograph
 - U.S. Passport or Passport Card
 - U.S. military ID card with photograph
 - Permanent resident card with photograph
 - Native American tribal ID Card with photograph
 - Foreign government-issued passport with photograph
 - Canadian provincial driver's license with photograph
 - Indian and Northern Affairs Canada card with photograph (INAC)
 - Transportation worker ID with photograph (TWIC)
- Valid license to practice in your healthcare profession (**can be a printout or electronic copy**)
- Certificate of completion of training provided by an accredited training organization (**can be a printout or electronic copy**).
- Photo of candidate will be taken by proctor at check-in.
- **Note: Marriage/Divorce documents can be presented onsite to confirm a name change.**
